Claiming R&D

THE PROCESS

R&D tax claims require a collaborative effort between the client, and Harmony Consulting - but we are here to guide them through the process every step of the way to make it as easy as 1, 2, 3...

1 TECH CALL - TECHNICAL PROJECTS INFORMATION

A discussion with an assigned Technical Consultant to determine a list of projects, and detail around the qualifying activities which took place to overcome the technical problems to achieve a significant improvement in technological methods, systems, products, or practice.

2 GATHER FINANCIAL DATA

Once the client has sat the tech call with our team, they will receive a financial data request email detailing the information we need for the financial assessment. This will include a copy of the payroll inclusive NI and pension contributions, subcontractors, consumables (material costs), and any software licenses (including data licenses/cloud computing costs), along with a copy of the full accounts and trial balance for the relevant period.

3 COST COLLECTION CALL - ASSIGN THE VALUE OF THE CLAIM

Once we've received the financial data in full, we'll arrange a call to talk through the costs and assign a percentage of the cost to R&D. During this call the team member will talk you through the report as it stands, clarifying the qualifying projects. Following the call our finance team will then finalise the assessment to determine the final value of the claim.

LEAVE THE REST TO US

Once the 3 steps are complete, we will prepare the report, and accompanying documents for your full formal review, and you'll receive an email explaining the value of your benefit and how it will be received (either as a tax reduction or a cash payment). We submit the AIF (Additional Information Form), which includes the key elements of the technical report, directly to HMRC, and we provide the computations for review by the client's accountant.
